### **Right to Information Request 5 May 2020**

I refer to your request pursuant to the *Right to Information Act 2009* ("RTI Act") received on 5 May 2020 by Hydro Tasmania.

I am authorised to make decisions on behalf of Hydro Tasmania in respect of applications for information under the RTI Act.

### 1. Your Request

Your request is set out in detail in column 1 of Annexure 1 to this letter. It will be collectively referred to in the body of this letter as "the Request".

### 2. Determination and Reasons for Determination of Request

- 2.1. Annexure 1 sets out my determination by itemising the sections of your request. As has previously been communicated to William Roberts, Hydro Tasmania has already submitted a large amount of information to the independent government review team for their review into the Tasmanian floods of June and July 2016. Hydro Tasmania has further disclosed information about our cloud-seeding operations by way of previous assessed disclosures pursuant to the RTI Act, available to the public on our website.
- 2.2. I have determined that sections 1 and 2 of the Request are refused pursuant to s 12(3)(c)(i) of the RTI Act on the basis that, to the extent you would have been eligible to be provided with it, that information is otherwise available. A link to information relevant to the Request is provided in Annexure 2 to this letter. Please note that Annexure 2 is provided for your ease of reference only it should not be considered exhaustive or a complete list of public sources of relevant information.
- 2.3. In relation to the balance of the Request, I have undertaken a search of the information held by Hydro Tasmania and its subsidiaries to locate any records that may be relevant to the Request and determined that:
