Right to Information Request 17 December 2020

I refer to your request pursuant to the *Right to Information Act 2009* ("RTI Act") received on 17 December 2020 by Hydro Tasmania.

I am authorised to make decisions on behalf of Hydro Tasmania in respect of applications for information under the RTI Act.

1. Your Request

Your request sought the following information:

All travel costs, including flights, accommodation, meals and taxi transport, incurred by the former Chief People Officer Mr Tanti during the course of his employment.

It will be collectively referred to in the body of this letter as "the Request".

2. Determination and Reasons for Determination of Request

- 2.1. I have undertaken a search of the information held by Hydro Tasmania to locate any records that may be relevant to the Request. Annexure 1 summarises the accounting data and credit card records related to travel costs (accommodation, airfares, ground transport and meals) per year of Mr Tanti's employment.
- 2.2. By way of explanation, I note that Annexure 1 includes total costs for meals each year and in total over Mr Tanti's period of employment. A significant portion of the total meal costs were associated with meetings or work events rather than travel specifically, and a breakdown of the total meal costs over Mr Tanti's period of employment reflecting this distinction has been included in Annexure 1.



3. Review of Rights

You are entitled under Section 43 of the RTI Act to apply for a review of the decision made under Part 2 of the determination.

Any request for such a review should be made in writing within twenty (20) working days of receiving this letter and addressed to:
